**Call to Order**

DeAnna Timmermann, Assembly Chair, called the meeting to order at 3:22 p.m. in Huber Auditorium.

**Provost's Update**

Provost Miller reported that an email was sent out to the campus regarding restructuring the faculty governance based upon recommendations from the governance committee. The committee plans to meet with various groups on campus to obtain further recommendations. The committee plans to present the final governance constitution in April 2007.

Provost Miller discussed the recent OUS board meeting. The Board is presenting the capitol budget to the Legislature, which will include the Pierce Library as a high priority, as well as the Hermiston Center project. On February 12, regional universities will be testifying before the House of Representatives about our needs. Regarding the portfolio conversation we will need to present our strengths, weaknesses, visions, etc including our strategic plan which will be presented at the June board meeting. Documents will be on OUS website. The Provost then mentioned that last week the re-accreditation meeting was held and that accreditation was coming up.

**Discussion Items:**

1. **Strategic Plan.** Provost Miller discussed the EOU 06-09 Strategic Plan and how we need to look at goals and outcomes. He talked about the process and how it got to this point.

Sarah Witte shared information about the SWOT workshops and said that there would be a SWOT summary report forthcoming. Templates for goals will be distributed to departments to fill out and then synchronized into a university set of goals that align with the OUS strategic plan. They are aiming at having another facilitated session by spring break.

**Information Items:**

1. DeAnna announced that the PowerPoint presentation and links to the OUS website from the January 8, 2007 Special Assembly regarding retirement benefits is posted on the Assembly website.

**5-Minute Access:**

1. **Association of Oregon Faculties (AOF) Report** – Greg Monahan spoke about legislators and their support of higher education. He talked about the state employee's compensation package and what it entails. He also mentioned that there are 6 court cases currently open regarding PERS. Greg talked about AOF and recommended that all faculty join and he has the forms if there is interest. A short question & answer period followed.
2. **Faculty Athletic Representative (FAR)** – Jeff Dense displayed and talked about athlete's academic majors, grade point averages, percentage of team members that are on the dean's list and the percentage of students that are on warning, probation or suspension. GPA, dean's list, academic warning, probation or suspension benchmarks were set up for the teams to obtain and he went on to share how pleased they were with how the teams had done as well as a job well done by the coaches.
3. **Athletics** – Rob Cashell publicly acknowledged Jeff Dense for all of his work to provide the above data regarding student athletes. Student athletes also compete and are eligible for awards. Rob shared some of the accomplishments the students had made.
4. **Academic Standards Committee** – Mary Koza stated that students that go on academic warning, probation or suspension have been being notified by letter at the end of each term. They were also asked to attend an academic workshop but the number of

students doing so has dropped. Beginning this term, students on warning or probation are to contact or meet with their advisors. The advising council is currently updating their website and here will be training for faculty.

5. **Center for Teaching, Learning and Assessment (CTLA)** – Curt Whittaker went to the website [www.eou.edu/ctl](http://www.eou.edu/ctl) and shared an update regarding CTLA's mission and goals which are both located on the website. A survey will be produced to ask faculty to determine if needs are being met.
6. **President's Council on the Statue of Women (PCSW)** – Jill Gibian shared that there would be a Women of Vision and Courage celebration happening on March 8<sup>th</sup> which is International Women's Day. There are three categories for nomination, a student, a faculty/staff member and a member of Union County. Jill has forms and encourages people to submit nominations along with three letters of support. The deadline is February 19, 2007 by 5:00 p.m.
