1. Approval of Minutes

 - Course name change a motion was made and seconded to change BA 451 – Personnel Management to BA 451 – Human Resources Management (5 cr). Motion passed.

Committee will be visiting with specific groups to collect preliminary information about the possible conversion.

- b. AFPC Update Jim Kreider discussed a proposal that will be brought forward to the Assembly regarding the election process. This proposal is a Bylaw issue and we do not know what will need to take place in order for this to change, if approved.
